Through project ROHU–370 a number of 568 persons benefit from all the joint local employment initiatives, training activities and participate in job fairs.	
Through the ROHU-370 project a Cross-Border Mobility Centre, at the headquarters of the Chamber of Commerce, Industry and Agriculture Satu Mare, is created through the renovation of the building. As a result, the employment opportunities increase for 304 persons participating in joint career orientation events and labour market forums. Also, 264 persons are better trained and more prepared for the labour market after attending cross-border entrepreneurial training programmes, joint vocational training and cross-border internship program
