DECISION No. 18

05th of February 2025

Approving the rejection of project ROHU 00511, transfer of ERDF funding under the 1st Open call for proposals, to entirely cover the financing of projects ROHU 00458 and ROHU 00469, as well as the financing of project ROHU00147, included on the reserve list of SO 2.2., in the context of Interreg VI-A Romania-Hungary Programme

Having regard to:

- Articles 22 of Regulation (EU) no. 2021/1059 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 24 June 2021 on specific provisions for the European territorial cooperation goal (Interreg) supported by the European Regional Development Fund and external financing instruments,
- Section 4 of the Interreg VI-A Romania-Hungary Programme,
- Rule 1(2)(3)(4) of the Rules of Procedures of the Monitoring Committee of the Interreg VI-A Romania-Hungary Programme,
- MC Decision 12/12.11.2024, approving the ERRAT to Decision 11/8th of November 2024, approving the List of projects selected for support under Priority 1 in the context of the 1st Open Call for project proposals within the Interreg VI-A Romania-Hungary Programme,
- <u>MC Decision 16/10.01.2025</u>, approving the List of projects selected for support under Priority 2 in the context of the 1st Open Call for project proposals within the Interreg VI-A Romania-Hungary Programme,
- MC Decision 17/10.01.2025 approving saving the available ERDF under Priority 3, ISO 6.3 until the reassessment process of the projects under Priority 2 will be finalized

The Monitoring Committee of the Interreg VI-A Romania-Hungary Programme has adopted this:

DECISION

Article 1. This document approves the rejection of project ROHU00511¹, selected under Priority 1, Specific Objective 2.4, as non-eligible, following the withdrawal of PP2 - University of Szeged, due to the 5 projects / partner / call eligibility rule provided for in the Applicant's Guide, chapter 2.2.1.1. Thus, EUR

1,120,675.61 ERDF becomes available under Priority 1 and shall be used as provided for in Articles 2, Article 3, and Article 4 below.

Article 2. This document approves the additional allocation of EUR 662,597.94 ERDF to project ROHU00458², selected under Specific Objective 2.4, to fully cover the requested ERDF, i.e. EUR 1,520,000.

Article 3. This document approves the transfer of EUR 432,170.97 ERDF from Specific Objective 2.4 to Specific Objective 2.2, and the award of this additional amount to project ROHU00469³, to fully cover the requested ERDF, i.e. EUR 1,599,345.71.

Article 4. This document approves the modification of MC Decision 17/10.01.2025 and the financing of project ROHU00147⁴, selected under the reserve list of Priority 1, Specific Objective 2.2, with a total ERDF budget of EUR 999,481.60, to be covered as follows:

- transfer of EUR 25,906.70 ERDF from Specific Objective 2.4;
- transfer of EUR 7,200.10 ERDF from Specific Objective 2.7;
- transfer of EUR 966,374.80 ERDF from Priority 3, Interreg Specific Objective 6.3.

Article 5. The revised List of projects selected for support under Priority 1 in the context of the 1st Open Call for project proposals within the Interreg VI-A Romania-Hungary Programme is attached to the present Decision and part of it.
